- 768,000 patients; 68% are under the federal poverty level; 54% are underinsured; and 31% are uninsured.
- 1 in 6 San Diegans receive their health care at HCP member sites.



Legislative Advocacy Success

- A commitment from CA Senator Barbara Boxer on the extension of Health Center funding.
- Successful passage of HR2, the Medicare Access and Children's Health Insurance Program (CHIP) Reauthorization Act.
- Unanimous support from our state legislative delegation on four priority bills that impact federally qualified health centers (SB-147, authorizing an alternative payment methodology; SB-610, finalizing rate changes at rural health clinics; AB-858, providing coverage for marriage/family therapists; and, AB-1130, increasing hours for primary care clinics).
