Community clinics and health centers provide HIV testing to more than 700,000 people, and provide HIV or AIDS care/treatment to approximately 9% of Americans with living with HIV. Rene Bennett will address best practices, successes and challenges in standardizing HIV testing in clinical FQHC settings. Learn about the successful HIV testing initiatives in LA County and across the country. Dr. Falvey will present data and lessons learned from the Christie's Place program "CHANGE for Women." This innovative program addresses trauma-related barriers for women of color living with HIV or AIDS. Dr. Flavey will share how staff successfully identified San Diego women living with HIV or AIDS who had fallen out of care, and how they proactively addressed the barriers to care to help ensure clients received their necessary HIV medical care. With the full implementation of the Affordable Care Act (ACA), more people than ever are able to access free or low-cost health insurance and, as a result, primary care services. However, people still need to be reached, educated about their options, and successfully enrolled in health insurance. Community clinics and health centers are playing a key role in developing and implementing innovative strategies to increase access to care through outreach and enrollment efforts. Community Health Alliance of Pasadena (ChapCare) has designed an ambitious strategy to educate and enroll the broader community into coverage that includes community enrollment events, a collaborative local initiative, and the use of new screening tools and technology. According to the Centers for Disease Control, prescription drug abuse is an epidemic and drug overdose death rates in the United States have more than tripled since 1990. Many communities are experiencing increased rates of unintentional death due to drugs with an increasing percentage related to prescription drugs. At the same time, primary care providers are being challenged to manage an increasing number of patients with chronic pain and prescription drug use. Community clinics and health centers, emergency departments, prescription drug abuse initiatives, pharmacies, medical societies, schools of pharmacy and county health departments are forming partnerships to address these issues. This session will include a discussion of the scope and magnitude of the problem, barriers to care, and potential solutions to reduce abuse. The panel will highlight strategies, partnerships and outcomes from two communities that have implemented county-wide initiatives to reduce prescription and over-the-counter drug abuse in our communities with an emphasis on effective chronic pain management.

## Integrating Clinical Pharmacy Services to Achieve the Triple Aim – Lessons Learned from a CMS Innovation Award

## **Description:**

In 2012, the USC School of Pharmacy and AltaMed were awarded a Centers for Medicare & Medicaid Services (CMS) Innovation Award to evaluate clinical pharmacy integration services. The program integrates ten clinical pharmacy teams into ten AltaMed clinics (including three PACE centers) and will compare quality, safety, and cost measures to AltaMed clinic sites without clinical pharmacy services. The program also will include a video telehealth component to explore options to provide clinical pharmacy services remotely to clinics with limited space or relatively small patient populations. The projected net savings in healthcare costs attributed to clinical pharmacy services is over \$30 million. Interim quality, safety, satisfaction, and acute care utilization measures will be shared during the session. Attendees will learn about the keys to justify, develop, and implement a clinical pharmacy service and lessons learned from the CMS program will be discussed.

## **Description:**

Managing high risk, high utilization and high cost patients is an increasing priority for safety net providers. More and more organizations are adopting intensive case management programs and other targeted interventions to improve health outcomes and reduce utilization and cost for their high risk patient populations. This session will focus on Project 25 - a three-year pilot program funded by the United Way of San Diego County to address the needs of chronically homeless, who are frequent users of public services. Partners include health care, law enforcement, housing and other social service providers. Services provided include a housing first model, intensive case management, a harm reduction approach for substance abuse treatment, and a patient centered medical home. Come learn about this innovative program, characteristics of the high utilizing patient population, services offered and evaluation of the effectiveness and cost savings of the program. Panelists will discuss the outcomes of Project 25, including details about the cost savings and challenges working with this patient population. In addition, the presentation will include information about progress on identifying sustainable funding for Project 25.

## **Description:**

Payers, including state Medicaid programs, are attempting to move away from the "fee for service" model that is considered largely to blame for rising health care costs and inefficiencies. Instead of compensating health care providers for the sheer volume of visits and procedures performed, payers want to reward providers and have them be accountable for helping patients hit well-defined health outcomes and benchmarks. Some of these efforts have "spillover" effects to transition Medicaid Health Center Prospective Payment System (PPS) to an Alternative Payment Methodology (APM) that encompasses value-based purchasing. However, these efforts will be catalysts for change and require a reorganization of the health care system. This session will feature a conversation with a panel of clinical and financial experts to discuss their views and concerns regarding payment reform and a delivery system transformation that will help develop a model of payment that effectively supports patient centered care.
