# WORKFORCE COMMITTEE / EXECUTIVE SUMMARY

# California Future Health Workforce Commission

CPCA signed on to a letter with the Greenlining Institute, Latino Coalition for a Healthy
California, Latino Physicians of California, and others to urge the Commission to prioritize the
needs of communities of color and other disadvantaged populations most impacted by poor
health outcomes and barriers to employment. CPCA also plans to write a separate letter to
the Commission to express community health center specific needs and interests.

# Goal 2: Advancing Primary Care Training

- CPCA continues to work with the California Academy of Family Physicians and the California Medical Association to adjust award levels and funding structures for primary care residency program awards through the Song Brown Program. The 2018-2019 Song Brown application cycle opened on April 11th and will close on May 14th.
- Congress reauthorized the federal Teaching Health Center Graduate Medical Education Program (THCGME) through the end of Fiscal Year 2019 at double the prior annual appropriations level \$126.5M.

# Goal 6: Growing and Diversifying Health Center Professions

- In November 2017, HRSA updated 4,159 geographic, population, and other facility HPSAs based on national, standardized data sets along with data provided by State Primary Care Offices (PCOs). The next phase of the Shortage Designation Modernization Project will focus on Automatically Designated HPSAs (Auto-HPSAs), with a national update tentatively planned for April 2019.
- CPCA continues to work with Gallagher Integrated to incorporate community health center
  data into Gallagher's annual Physician Compensation and Production Survey, a national
  physician compensation survey. CPCA members who participate in this survey will receive a
  free copy of Gallagher's Integrated 2018 Physician Compensation and Production Survey
  along with a custom report with CPCA member only data cuts. In addition, our organizations
  will be working together to host a three-part webinar series on physician compensation
  throughout spring and summer 2018.
- Building on initial research conducted as part of the Clinic Leadership Institute (CLI), CPCA is aiming to lay the groundwork for a landmark CPCA student initiative. CPCA's 2018 summer workforce intern will evaluate the research findings and continue to design an initial program concept for the statewide student initiative program at CPCA.

## Goal 7: Serving as a Catalyst and Coordinator

- New data from *California's Current and Future Behavioral Health Workforce*, a report released in collaboration with the Healthforce Center at UCSF, California Health Care Foundation, and CPCA, shows that substantial investments are needed.
- CPCA spent the last month tracking bill activity and organizing bills that are aligned with the Primary Care Workforce Policy Coalition priorities. The next Coalition call is scheduled for Tuesday, May 1, during which time Coalition members will agree to joint advocacy efforts on a prioritized set of bills.

# **Workforce Legislation**

- CPCA has expanded the workforce legislation it is tracking to better incorporate policies impacting the workforce pipeline, including educational equity legislation.
- CPCA continues to track key workforce issues in the FY 17-18 state budget, including the continuation of the \$100 million primary care workforce commitment.

# Call to Order

The meeting was called to order by the chair at 11:43 AM.

#### Approval of Agenda

# **Approval of Minutes**

A motion was made and seconded to approve the minutes as written. The motion carried.

Beth Malinowski gave members an overview of the Workforce 2017 Year in Review, noting what the committee had projected in January of 2016 which focused on the 9 key primary care priorities established in the Horizon 2030 report and laid the ground work for 2017. Beth then reviewed the 9 priorities and the key activities that took place throughout 2017, along with the 7 goals for 2018 which are in-line with CPCA strategic plan.

The Workforce Committee Chair, Paulo Soares, reminded members that this is a young committee and that we need to make sure we're meeting goals, so as you see new challenges to please remember to bring them back to this committee.

# California Future Health Workforce Commission

Dean Germano, who serves on the California Future Health Workforce Commission gave members a summary of this week's meeting which focused on breaking silos. They're staying hopeful that they

can get something done in a short time period. One positive is that CPCA and CCHC's are getting more representation.

# Goal 2: Advancing Primary Care Training

Nataly Diaz updated members on The Song-Brown Healthcare Workforce Training Program which received a \$33M installment of new funds in 2017 due to a strong coalition effort led by CaliforniaHealth+ Advocates, California Academy of Family Physicians, and the California Medical Association. And, at the November 29-30, 2017 Commission meeting, all health center primary care residency program applicants received funding amounting to \$7M or 20% of the available 2017 funds.

We were happy to see that all of health center applicants were awarded funding by the Commission to support their existing and new primary care residency programs.

- Valley Health Team
- North East Medical Services
- Clinica Sierra Vista
- SAC Health System
- Family Health Centers of San Diego
- Borrego Health

While more work is needed to secure additional Song Brown funding and address application issues, this is a significant victory at a critical time.

Nataly noted that The Continuing Resolution (CR) approved on December 21, 2017 includes limited funding for the Teaching Health Center Graduate Medical Education (THCGME) Program through March 31, 2018. This funding, along with the funding extensions of community health centers and NHSC, comes at the expense of the ACA Prevention and Public Health Fund.

# Workforce Strategic Plan Update

Beth reviewed and discussed CPCA's workforce strategic plan activities which covered the following:

- CLI Emerging Health Leaders Program in which Beth is a CLI Cohort 10 participant, they are aiming to lay the groundwork for a landmark CPCA student initiative.
- CPCA successfully coordinated a third statewide Workforce Policy Coalition meeting in November 2017.
- The Coalition successfully ended the year by jointly agreeing to prioritize three issues areas in 2018; residency redesign, equity in education (focused on college pipeline programs), and researching primary care specific tax incentive programs
- CPCA continues to work with UCSF's Healthforce Center on a series of primary care workforce reports funded by Kaiser Permanente Community Benefit. Report #3, *Primary Care Workforce Strategies*, a look at promising practices from across the country, is in final draft form is expected to be released shortly.

- Health Careers Connection. Once again, CPCA is partnering with Jeff Oxendine and his team at the Health Careers Connection (HCC) program in Berkeley to help place interns with community health centers across the state. The HCC program connects organizations in all health sectors with talented and diverse future health professionals and leaders. Their goal is to inspire and empower interns and alumni with real world exposure, experience, mentoring and networking that assists them in achieving their goals, while supporting host organizations to meet their workforce, diversity, community health and other priority goals.
  - o CPCA will be sending out more information to members later this month, and will also host at least one intern in the Association's office over the summer.
  - o Discussion took place around the challenges listed below:
    - Internships need to give back or benefit the CHC
    - The dedication of time, resources and dollar is significant
    - There is a great need to promote diversity
    - We need to be able to track where these interns are in 5 years
    - Will they stay in the area, is there a tie to the community that may make them come back
    - Diversity needs to be is a huge/built in part of this program
    - There needs to be a program in place, invest time up front

# I. CPCA Administrative Advocacy

CPCA, along with the California Academy of Family Physicians and the California Medical Association, conducted administrative advocacy at the February 2018 Song Brown Commission meeting to adjust award levels and funding structures for New and Expanding Primary Care Residency Programs. Our three organizations worked together to create a joint letter, which was then used during public comment at the February meeting. We advocated that:

- New Primary Care Residency Program Awards
  - *Item #1:* Programs accredited after July 1, 2016 should continue to be able to apply for funding.
  - Item #2: Programs should continue to receive up to \$800,000 per award.
  - *Item #3:* Programs should be able to apply multiple times until receiving the maximum amount.
  - *Item #4*: Programs should continue to be allowed to apply if they are not accredited at the time of application.
- Expansion Primary Care Residency Program Awards
  - Item #1: An eligible program should demonstrate that it is meeting Song Brown's goals and will use the award to help fund training for an additional resident, even if the slot was approved by ACGME several years ago.
  - *Item #2:* If the existing primary care residency program does not receive official expansion approval from ACGME prior to subsequent Song-Brown funding, it should be required to reapply.
  - Item #3: The maximum funding amount for expansion slots should be adjusted to \$300,000 per three-year cycle to more closely reflect the true cost of PCR program expansion.

## II. Song Brown Commission Decisions

The Song Brown Commission accepted most of our recommendations with the exception of the following:

New Primary Care Residency Program Awards

- Item #3: A new program can only receive new program funding one time. A new program is a program that will receive accreditation after July 1, 2016, but has not enrolled its first cohort. Programs cannot apply for existing programs and new programs in the same application cycle.
- Expanding Primary Care Residency Programs
  - Item #1: The ACGME letter demonstrating approval for expansion must be dated after July 1, 2016. The letter must state how many slots the program is currently approved for, how many expansion slots the program is approved for, and the effective date of expansion.

# III. Moving Forward

The 2018-2019 Song Brown application cycle opened on April 11th and will close on May 14th. Melissa Omand from OSHPD will be present at the May 8<sup>th</sup> Residency Peer Network meeting to answer any questions community health centers may have about the Song Brown application. OSHPD and the Song Brown Commission continue their subcommittee work to evaluate ways to measure time spent at continuity clinics, exclusivity in primary care, and Song Brown outcomes. They are also exploring the potential of including HRSA's definition of "economically disadvantaged" in their questions about the diversity of residents and graduates. CPCA will be present at the June 2018 Song Brown policy meeting for additional advocacy.

# I. California Future Health Workforce Commission

The California Future Health Workforce Commission convened on February 13th for their third meeting. Co-chairs from each subcommittee (primary care, behavioral health, and geriatrics) presented initial strategies to known workforce problems and asked Commissioners to provide input, especially around timing and financial constraints in development and implementation, and around identifying opportunities for additional stakeholder involvement. Subcommittees and staff are now working to incorporate the Commission's feedback into the cross-cutting strategies, infrastructure strategies, and subcommittee-specific strategies.

CPCA signed on to a letter with the Greenlining Institute, Latino Coalition for a Healthy California, Latino Physicians of California, and others to urge the Commission to prioritize the needs of communities of color and other disadvantaged populations most impacted by poor health outcomes and barriers to employment. A copy of the joint letter is provided in the resources section of this memo. CPCA also plans to write a separate letter to the Commission to express community health center specific needs and interests.

# II. CPCA Workforce Strategic Plan Activities - Goal 2: Advancing Primary Care Provider and Staff Training

# Federal Advocacy – THCGME Program

Congress reauthorized the federal Teaching Health Center Graduate Medical Education Program (THCGME) through the end of Fiscal Year 2019 at double the prior annual appropriations level — \$126.5M. In addition to providing THC funding for two fiscal years, the Balanced Budget Act also directed HRSA to take into account the cost of training residents and the impact of the per resident allocation (PRA) on THC programs. Due to some initial concern, AATHC and our California community health centers used their advocacy strength to establish a PRA that would provide sufficient funding related to the average cost of training a resident. HRSA, in turn, set the PRA at \$150,000 per resident. These outcomes were the result of strong health center advocacy coupled with powerful support from the American Association of Teaching Health Centers (AATHC). Thank you for your hard work!

# III. CPCA Workforce Strategic Plan Activities - Goal 6: Growing and Diversifying the Health Professions

# o HRSA Shortage Designation Modernization Project

HRSA's Shortage Designation Modernization Project is an ongoing effort to modernize the shortage designation process with automated procedures and standardized data sets. The goal of the initiative is to provide greater transparency, accountability, and parity to the Health Professional Shortage Area (HPSA) designation and scoring process. The project does not change the criteria used for designating or scoring HPSAs, but instead reevaluates the data sources.

In November 2017, HRSA updated 4,159 geographic, population, and other facility HPSAs based on national, standardized data sets along with data provided by State Primary Care Offices (PCOs). The next phase of the project will focus on Automatically Designated HPSAs (Auto-HPSAs), with a national update tentatively planned for April 2019. Please keep in mind:

- All Auto-HPSAs will be included in the national update based on standardized data sets and provider data reviewed and revised by State PCOs.
- o Auto-HPSAs will not lose their designations in the update.
- o To help Auto-HPSA facilities prepare for the planned update, HRSA will provide a series of impact analyses in 2018 and 2019.
- The impact analyses will be a test run of the national update based on data at a single point in time. The reports will be informational only and will not be used to make program decisions.
- o National, State and individual Auto-HPSA organization level reports will be available. Each data point used to generate the Auto-HPSA facility's score will be provided.
- o The first impact analysis results are expected to be available in August 2018.

# Gallagher Integrated National Physician Compensation Survey

CPCA continues to explore new opportunities with Gallagher Integrated that bring value to CPCA members. This includes working with Gallagher Integrated to incorporate community health center data into Gallagher's annual Physician Compensation and Production Survey, a national physician compensation survey. CPCA members who participate in this survey will receive a free copy of Gallagher's Integrated 2018 Physician Compensation and Production Survey along with a custom report with CPCA member only data cuts. CPCA shared this opportunity with members earlier this month. It is worth noting that this survey is separate and distinct from the CPCA Compensation and Benefits Survey, which is scheduled for release in summer 2018.

# Physician Compensation Webinars

CPCA, in collaboration with Gallagher Integrated, will be hosting a three-part webinar series on physician compensation throughout Spring and Summer 2018. This series is designed to increase knowledge of designing compensation plans and strategies that fairly compensate providers, comply with legal requirements, and align with the mission and culture of community health centers.

# UCSF Behavioral Health Workforce Report

New data from *California's Current and Future Behavioral Health Workforce*, a report released in collaboration with the Healthforce Center at UCSF, California Health Care Foundation, and CPCA, shows that substantial investments are needed. California has more than 80,000 licensed behavioral health professionals, but they are not geographically dispersed or demographically reflective of our population. It is also concerning is that only 55% of practicing psychiatrists served any Medicare patients and only 46% served any Medi-Cal patients in 2015. Forecasts for demand based on current service utilization plus unmet need for services indicate that by 2028, California will have 50% fewer psychiatrists and 28% fewer psychologists, LMFTs, LPCCs, and LCSWs than are needed.

CPCA is hosting a webinar on April  $12^{th}$  to review the important findings of this report, including top recommendations and action areas. The recording will be available on our CPCA On-Demand Training Library.

# Workforce Policy Coalition

As you might recall from January's report, the Workforce Policy Coalition successfully ended the year by prioritizing three policy areas in 2018; residency redesign, equity in

education (focused on college pipeline programs), and incentivizing the primary care workforce. On January 25 and 26, the three subcommittees held conference calls to share legislative efforts pertinent to their priority areas. CPCA staff then compiled a comprehensive list of workforce bills, which were reviewed with the larger Coalition on March 1. CPCA has spent the last month tracking bill activity and organizing bills that are aligned with the Policy Coalition priorities. The next Coalition call is scheduled for Tuesday, May 1, during which time Coalition members will agree to joint advocacy efforts on a prioritized set of bills.

# Promoting Community-Based Primary Care Workforce Visibility

# California Community Colleges

Economic insecurity is expected to increase over the next decade. Millions of Californians would benefit from sub-associate degree credentials or short bursts of additional training to move ahead in today's economy. However, traditional higher education is not accessible for these working learners. The California Community Colleges is responding with an online community college to provide skills and credentials working learners need to improve their social and economic mobility and move our state forward. This new, competency-based online college will be unlike any other public online education platform and will focus predominately on sub-associate degree credentials of value tailored to the needs of these working learners.

Through partnerships with employers, industry sectors and organized labor, the online community college would offer the skills that match the jobs that employers are looking to fill. The college will create program pathways to include vocational training, upskilling and credentialing support for career education jobs in growing industries to ensure strong labor market outcomes and alignment with future educational and career pursuits. It is our understanding that healthcare will be one of the core components of this new online college.

# o <u>UCD Center for a Diverse Healthcare Workforce</u>

CPCA is continuing its partnership with the UC Davis School of Medicine's Center for a Diverse Healthcare Workforce. Over the last quarter, CPCA has focused on assisting the CDHW with the development of a community of practice focused on addressing the shortage of primary care providers in rural, remote and frontier areas. CPCA staff facilitated introductions of CDHW staff to representatives from the Health Alliance of Northern California (HANC) and Central Valley Health Network (CVHN). As a result of the introductions, an initial meeting was held at the UCD School of Medicine on April 5, 2018. Doreen Bradshaw and David Lavine from HANC, Mary Renner from CVHN, and Val Sheehan from CPCA were in attendance at the meeting. The goal of the meeting was to explore how the groups could work together to develop a strategy for strengthening the recruitment and retention of primary care providers in the Rural North and Central Valley. In terms of next steps, both HANC and CVHN will discuss

the opportunity for partnership with their respective health center members and a future conference call or virtual meeting with the planning group is targeted for May 2018.

# Area Health Education Centers (AHEC)

The CA AHEC Office and CPCA are working with Bob Redlo and the California Workforce Development Board to host a webinar in May 2018. The presentation and discussion will focus on creating stronger relationships between the local Workforce Investment Boards and community health centers. Registration information will be available in the coming weeks.

# Expanding Recruitment Support

# National Health Service Corp Program

The Bipartisan Budget Act of 2018 included funding for the National Health Service Corps for two years at \$310M per year. This was a solid victory for community health centers and stakeholders after months of intense negotiation.

In March 2018, Senators Smith (D-MN) and Murkowski (R-AK) introduced S. 2533, a bill that would allow mental and behavioral health providers under the NHSC to serve in "schools, community-based settings, or patient homes." The bill, named the "Improving Access to Mental Health Services Act" seeks to increase the flexibility for NHSC members to serve in schools beyond those that are designated school-based health clinics. The Senators are seeking to increase access to mental and behavioral health services in schools, and are looking to move the bill in an upcoming mental health or opioid package.

# Reducing Recruitment Barriers Associated with Primary Care Providers

# Association of Clinicians for the Underserved (ACU)

CPCA continues to partner closely with the Association of the Clinicians for the Underserved around their STAR2 Center's training and technical assistance work. As a reminder, through a National Cooperative Agreement with the Bureau of Primary Health Care, the STAR2 Center offers a number of free services, resources, and trainings to health centers to help them address their clinician recruitment and retention challenges. This includes for selected health centers, a free, one-day on-site technical assistance session by workforce experts. CPCA has been notified that ACU has funds to provide onsite technical assistance to one health center, and we have been asked to attend the technical assistance onsite session to support ongoing technical assistance as needed. Sites are being chosen based on needs identified through their Recruitment & Retention Data Profiles, which were sent to each health center back in November of 2017. We are currently awaiting site selection confirmation from ACU.
