Legislative and Advocacy Success

- Secured \$100 million investment for primary care workforce funding from California legislators, accepted into California 2017-18 fiscal year budget.
- Improved patient access to mental health services by passage and adoption of AB 1863, adding Marriage and Family Therapists (MFTs) as qualified providers at federally qualified health centers.
- Successful resolution of dental audit discrepancies between CA Department of Health Care Services (DHCS), Centers for Medicare & Medicaid (CMS) and California health center programs. Spurred the formulation of standards to be used in future audits.



Quality Multi-Lingual Care in Diverse Communities

- 17 member health centers and other safety net providers.
- 133 member practice sites in 3 counties: San Diego, Imperial and Riverside.
- 827,000 patients; 68% are under the federal poverty level; 54% are underinsured; and 31% are uninsured.
- 1 in 6 San Diegans receive their health care at HCP member sites.
