**July UPDATE**  
**2019**



The Health Homes Program in San Diego (Group 3) became effective July 1, 2019. Due to the amount of deliverables each of our 7 Healthy San Diego Plans had to complete prior to the July 1, 2019 implementation date, the monthly Healthy San Diego Health Homes Work Group was suspended beginning with the May 24<sup>th</sup>, 2019 meeting. The next Healthy San Diego Health Homes Work Group will be September 27<sup>th</sup>, 2019. A meeting notice is forthcoming. The following are highlights of key activities we worked on collaboratively.

- Our 7 Healthy San Diego Managed Care Plans completed their DHCS Health Homes Programs deliverables due March 1 and July 1 2019.
- Prior to the July 1, 2019 implementation date, the Plans were required to provide trainings to our contracted Community Based – Care Management Entities (CB-CME). The Health Homes Work Group Leadership Team which consists of our 7 Healthy San Diego Health Plans facilitated two Webinar Trainings for our contracted and soon to be contracted CB-CME's. Additional trainings were provided by each health plan independently.
- The Corporation for Supportive Housing (CSH) developed Health Homes provider and Community Based Organization trainings. The first training was held on June 6<sup>th</sup> in the South Bay, the second training was held June 19<sup>th</sup> in Central San Diego and the final training is scheduled for July 17<sup>th</sup> from 10:00 to 12:00 at Live Well Escondido. - On May 13, 2019 we held our Health San Diego Health Homes Kick Off Event at the County Operations Center in Kearney Mesa. Attendance was 137. Speakers were Brian Hansen from the DHCS, Susan Bower from HHSIA Integrated Services, Ryan McDonald from Harbage Consulting and Greg Knoll from the Consumer Center for Health Education & Advocacy. Comments following the 2 ½ hour event were very positive as our speakers did an outstanding job. This event was in partnership with the Healthy San Diego Health Education & Cultural and Linguistics Work Group.
- The next DHCS deliverable due is the Mental Health MOU Addendum. This is due August 1, 2019. Under the Healthy San Diego Behavioral Health Subcommittee, the County Mental Health Plan (MHP) and our Medi-Cal Managed Care Plans have had an existing MOU to facilitate care coordination since July 1, 1998. We have amended this MOU several times including the following:
  - Coordinated Care Initiative (CCI)
  - Health Plan coverage for Mild to Moderate mental health conditions
  - Drug Medi-Cal Organized Delivery SystemThe MOU Addendum to include the Health Homes Program will add a paragraph that speaks to coordinating care for members with mental health conditions. The Mental Health Addendum will be submitted collaboratively to DHCS by Friday, July 19, 2019.
