The Healthy San Diego Behavioral Health Subcommittee Health Homes Work Group meeting scheduled for May 24, 2019 is cancelled. The next meeting will be June 21, 2019 from 11:30 AM to 1:30 PM at 211-San Diego. The Agenda with call in information will be sent two weeks in advance. The purpose of this update is to provide our collaborative with our accomplishments since our last meeting on April 26, 2019.

- Our 7 Healthy San Diego Managed Care Plans continue to work on their March 1, 2019 deliverables to DHCS. DHCS requested additional information from some of the Plans.
- On May 8<sup>th</sup> a Joint Statement from the Potential CB-CME's was received as a follow up with additional recommendations. The recommendations were regarding Eligibility Lists, Central Enrollment and Multiparty Authorizations. Additionally, Health Center Partners sent 7 questions regarding the following: Common tools, common certification requirements, common reporting requirements, Health Action Plan template, HHP Qualification & Tier Questionnaire, reporting template and work flows. The Health Plans collaboratively answered questions to the best of their ability using the attached Q&A form.
- On May 13, 2019 we held our Health San Diego Health Homes Kick Off Event at the County Operations Center in Kearney Mesa. Attendance was 137. Speakers were Brian Hansen from the DHCS, Susan Bower from HHSA Integrated Services, Ryan McDonald from Harbage Consulting and Greg Knoll from the Consumer Center for Health Education & Advocacy. Comments following the 2 ½ event were very positive as our speakers did an outstanding job. This event was in partnership with the Healthy San Diego Health Education & Cultural and Linguistics Work Group.
- The Corporation for Supportive Housing (CSH) has partnered with our Healthy San Diego Health Homes Work Group to provide trainings/presentations at provider and other offices. Additionally, CSH is doing 3 county-wide trainings.
