# An Overview of Telecare Services in San Diego County

Telecare is committed to providing recovery and rehabilitation services to individuals with serious mental illness (SMI). In San Diego County, we have a mix of programs that aim to serve people with SMI as well as complex needs including Substance Use Treatment Services (SUTS), Justice-Involved Mental Health (JIMH) and long-term institutionalization, as well as people who are not engaging in services at all.

Our programs help people engage in services, regain hope and strengths, overcome barriers due to stigma and symptoms, develop practical skills, and lead more meaningful and contributing lives, while also reducing or preventing re-hospitalization and recidivism.

# Integrated Services for Parolees

Opened in 2009, the Corrections Outreach Recovery Enhancement (CORE) San Diego program provides intensive case management services to individuals who are on parole, have a mental illness, and are at high risk for homelessness. CORE San Diego offers community outreach and engagement, case management, education and employment support, and benefits and housing assistance. By providing support and rehabilitation services, we reduce homelessness and recidivism.

#### **Post-Release ACT Services**

Since 2011, Post-Release Outpatient Program
Services (PROPS) has provided ACT/FSP services to
members who are re-entering the community on
probation after jail. Members participate in services
that address criminogenic risk in order to reduce
recidivism and avoid unnecessary psychiatric
hospitalization. By helping members bridge their
transition from jail to the community, we decrease
recidivism and support members in regaining their
hopes and dreams and achieving their goals.

#### **Reducing Recidivism**

Opened in 2015, the Behavioral Health Court (BHC) program is an active partnership between Telecare and the County of San Diego, the Superior Court of California—County of San Diego, the Office of the Public Defender, the Office of the District Attorney, the San Diego Sheriff Department, and the San Diego County Probation Department. Members are able to begin ACT/FSP services as soon as they are released from jail and are required to commit to the program for 18 months in order to participate. The primary focus of the program is to ensure members are set up with the proper resources and tools they will need to move forward without re-offending.

#### **Outreach and Engagement**

Opened in 2012, the In Home Outreach Team (IHOT) program was San Diego County's response to Laura's Law. Instead of court-ordering individuals to receive Assisted Outpatient Treatment (AOT) under Laura's Law, IHOT attempts to voluntarily engage adults resistant to mental health treatment. Through education, trust, and respect, the program aims to successfully link members with mental health services. This IHOT team covers the Central, South, and East County regions of San Diego and serves as a referral source to the San Diego AOT program.

#### **Assisted Outpatient Treatment**

Opened in 2015, the San Diego Assisted Outpatient Treatment (AOT) program provides ACT/FSP services to adults with SMI who have been court-ordered to receive services under Laura's Law. Program members may also have a co-occurring substance use diagnosis. Treatment is provided by a multidisciplinary team and all services are strengths-based and anchored in recovery principles. Individuals identified through assessment who do not voluntarily agree to services are required to go before a judge to determine the need for treatment.

#### Assertive Community Treatment (ACT)

Opened in 1994, Gateway to Recovery (GTR) is an ACT/FSP program that empowers recovery from within. GTR's teams meet members where they are, in the community, and provide intensive, personcentered, and recovery-based services. The teams help members navigate the mental health system and take positive steps toward the things that matter in their lives. The **Project 25** sub-component program offers limited housing subsidies to members who are identified as high-utilizers of mental health services and are at risk of homelessness.

### Assertive Community Treatment (ACT)

Opened in 2010, Pathways to Recovery (PTR) is an ACT/FSP program that provides psychosocial rehabilitative, recovery-oriented, intensive, community-based services to help members navigate the mental health system and take positive steps toward their recovery. **In-Reach** is a sub-component of PTR and works in conjunction with San Diego County Institutional Case Managers (CICM) to provide case-aide services that are focused on discharge planning and benefit coordination for CICM members residing in long-term care.

#### **Short-Term Case Management**

Opened in 1995, the Transition Team provides intensive, short-term case management services that help members navigate the mental health system and connect them to community services in a timely manner once they leave the hospital. The Transition Team is comprised of case managers who utilize Telecare's Recovery-Centered Clinical System (RCCS) to tailor services to members' unique needs and to help foster relationships that support goals.

#### **Older Adult Case Management**

Opened in 2012, AgeWise provides county-wide older adult case management to individuals age 60 and older and has two components: the Strengths-Based Case Management (SBCM) FSP and the Institutional Case Management (ICM) program. The SBCM FSP provides case management and mental health services with a focus on rehabilitation and recovery. SBCM also has housing subsidies for eligible individuals. The ICM program serves individuals who are on Public Conservatorship and reside in a skilled nursing facility or another county-identified long-term care institution.

#### **Case Management**

The Kaiser Program for Intensive Community
Support (PFICS) is part of Kaiser Permanente's
behavioral health continuum of care. The team
works in collaboration with Kaiser members to
reduce hospitalizations by providing intensive,
recovery-based case management services. To help
individuals optimize their Kaiser behavioral health
benefits and maximize recovery outcomes, Telecare
staff work in partnership with Kaiser psychiatrists
and therapists to provide members with supportive
visits, with the overarching goals of reducing harm
through connection with services and increased
utilization of resources.

# **Our Continuum of Care**

Telecare has partnered with San Diego County since 1990. Telecare's current programs are all community-based but the service models and approaches vary to meet specific population or community needs.

San Diego program models include Assertive Community Treatment (ACT), Full Service Partnerships (FSP), case management, and care coordination. Populations include adults with serious mental illness, people who have Justice-Involved Mental Health (JIMH) needs, and those who require supportive housing.

While our current programs are community-based, we have historically also provided sub-acute services for people who needed more structured, long-term support. Telecare provides acute, crisis, and residential services as well. Our intent to make it easy for people to move comfortably between our programs and have a seamless treatment experience. Our values, clinical practices, and culture of recovery are consistent across our programs, so people can stay more easily focused on their own healing process.

Telecare's goal is to provide a continuum of care that enables us to serve individuals in the least restrictive and most client-centered ways available—while helping the county to use its critical resources most effectively. Telecare leaders collaborate closely with the county to identify the best setting to provide targeted, personalized services for each individual.



#### SUB-ACUTE

Our sub-acute programs are supportive, structured, secure inpatient environments designed to help clients prepare to move to the community and/or lower levels of care. Length of stay is typically 3-6 months.



#### ACUTE

Our acute programs provide a safe, therapeutic, secure inpatient environment for people experiencing a mental health emergency. Services can be provided on a voluntary or involuntary basis. Length of stay is typically 3-10 days.



#### CRISIS

Our crisis programs help people experiencing mental health crises to regain a sense of stability and avoid more restrictive settings. Crisis programs are typically unlocked settings for people on a voluntary basis. Length of stay is anywhere between six hours to 30 days.



#### COMMUNITY-BASED

Our community-based services are designed for people who can successfully live independently in the community with intensive services and supports. Length of stay is typically 90 days, but can extend up to several years based on the program and individual need.



#### RESIDENTIAL

Our residential programs provide homelike alternatives for individuals with mental illness who would otherwise be placed in higher levels of care. Length of stay is a minimum of 12 months.

# **Future Focus**

# Expanding Our Services in San Diego

#### **New Programs Coming**

Telecare was awarded three programs that are scheduled to open in 2019.

The San Diego Justice-Involved Treatment Services and Supported Housing ACT/FSP program is designed to improve the mental health and quality of life of justice-involved adults in the community who have a serious mental illness (SMI). The program will aim to increase clinical and functional stability through the use of an intensive ACT/FSP team and by addressing criminogenic needs to reduce recidivism.

#### The San Diego County Step Down Acute Care ACT/FSP

program is designed to provide ACT/FSP services to individuals who are homeless with SMI who are leaving acute care facilities. Our aim will be to provide services so members can successfully

transition to the community and avoid unnecessary readmissions to acute psychiatric hospitals. Members who no longer require ACT-level care can still benefit from the program's housing resources and a lower level of ongoing support.

**The San Diego County Step Down Long-Term Care ACT/FSP** program is designed to provide ACT/FSP services to individuals with SMI who are transitioning out of long-term care facilities. In addition to providing team-based services that aim to avoid unnecessary readmissions, the program will actively partner with designated housing authorities to help meet members' housing needs.
