# **WORKFORCE COMMITTEE / EXECUTIVE SUMMARY**

# Residency Programming, Advocacy & Research

- To expand the existing knowledge set around the current state of residency programs in California's health centers, CPCA commissioned Schoen Consulting to complete an environmental scan between June 2017 and February 2018.
- Building off of our joint success with the \$100M state investment in primary care residency programs, CPCA received a grant to programmatically support the development of new, existing, and expanding CHC residency programs.
- In addition to securing the second third of the \$100M to the Song-Brown Commission for FY18-19, CPCA also advocated strongly for community health center primary care residency program applicants at the August 23<sup>rd</sup> Song-Brown Primary Care Residency Funding Meeting.
- CPCA nominated Dr. Debbie Lupeika, Shasta Community Health Center's Residency Program Director, to sit on the Prop 56 GME Advisory Council.
- SPA 18-0032 is still pending approval and if approved will be effective April 1, 2018. CPCA submitted formal comments to DHCS on June 29, 2018 after obtaining member feedback.

# **Workforce Retention Programming**

- CPCA continues to focus extensively on care team development in the community health center setting, and recognized that Medical Assistants (MAs) play a critical role in providing care and expanding capacity within care teams.
- CPCA consistently hears from members that MA training and retention efforts are challenging, with MA retention rates often ranging from 12 to 24 months at the most.
- It is CPCA's intention to develop a Medical Assistant training program and accompanying career-ladder development guide with the goal of supporting community health centers in their efforts to successfully onboard and retain qualified MAs.

# **Workforce Legislation Report**

- The FY 18-19 budget reaffirms the administration's commitment to primary care workforce by moving forward with the 2nd of 3 installments (\$31.3 million) to increase funding to the Office of Statewide Health Planning and Development (OSHPD) Song Brown Program. Funds were allocated consistently with the Budget Act of 2016 and 2017.
- The enacted budget also contains a one-time, \$1 million investment, to be directed through OSHPD, for a Primary Care Clinician Psychiatry Fellowship scholarship. Advocates are hopeful the application process to access these funds will be available next month.
- The legislature and administration reached an agreement on the FY 18-19 spending plan for the Proposition 56, California Healthcare, Research and Prevention Tobacco Tax Act of 2016

revenue. In addition to supplemental provider payments, funds will be directed to the following two workforce programs:

- Physician/Dentist Loan Repayment Program: Establishes the Proposition 56 Medi-Cal Physicians and Dentists Loan Repayment Act Program (\$220 million) to provide loan assistance payments to qualifying, recent graduate physicians and dentists that serve Medi-Cal beneficiaries.
- Residency: A one-time, \$40 million investment in primary care and emergency medicine residency, to be administered by the Physicians for a Healthy California (formerly the CMA Foundation).

# **Area Health Education Center (AHEC)**

• CPCA advocated strongly for changes to the AHEC Program by submitting a letter and organizing a conference call with HRSA.

# **HRSA's Shortage Designation Modernization Project**

 We anticipate HRSA's Auto-HPSA impact analyses will be individually disseminated to health centers in early-mid October. These impact analyses will specifically be sent to the CHC contacts noted in HRSA's electronic handbook.

# **General Updates**

- Earn & Learn Programs in Health Professions: AB 2015 The Department of Consumer Affairs (DCA), as directed by AB 2105 (Rodriquez, 2016), has been tasked with implementing a stakeholder engagement process to explore the development of Earn & Learn programs within health professions. Specifically, they will be pulling together a variety of stakeholders to explore Earn & Learn program development possibilities in four disciplines: Medical Assistants, Nursing, Specialty Imaging, and Mental Health. The first opportunity to learn about this work will be on October 2, 2018 at 1:20 PM.
- Communities of Practice CPCA, in partnership with HANC, CVHN, member health centers and UCD's Center for a Diverse Healthcare Workforce, continue to explore ways to increase the number of students from Far North and San Joaquin Valley who attend UCD School of Medicine, and who will likely choose to return to those communities to practice once they complete their medical education training. The goal of the Communities of Practice forum, if appropriate, is to create an Endorsed Applicant Partnership process by February 2019.
- CPCA Salary Survey A total of 126 organizations participated in this year's Compensation & Benefits survey. Gallagher Surveys is not analyzing the submissions and will make available both individual and statewide reports in mid-November.

# **Call to Order**

The meeting was called to order by Nichole Mosqueda at 10:11AM.

# **Approval of Agenda**

A motion was made and seconded to approve the agenda as written. The motion carried.

# **Approval of Minutes**

# **Workforce Legislation Report**

Beth Malinowski gave updates on the bills listed in the bill report and asked members for feedback and answered questions.

Rosa Vivian Fernández, San Benito Health Foundation CEO, made a recommendation to move legislation that would create an expedited licensing process at the California Board of Registered Nursing. No motion was made.

# **Workforce Policy Coalition**

Christina Hicks discussed the pieces of legislation that were identified as priorities for Coalition members based on the three identified policy areas for the 2018 legislative cycle. The Workforce Policy Coalition will hold its next call on Tuesday, July 17, to discuss and decide on needed advocacy strategies for the remaining bills moving forward.

# **California Future Health Workforce Commission**

Nataly Diaz reported that the Commission published an extensive list of potential strategies that Commissioners and Technical Advisory Committee members identified as possible solutions to address the health professions workforce crisis. To ensure members had input into the Commission's strategy development, CPCA led a member discussion through an electronic survey, which was used to prioritize the list of strategies offered. Survey responses were aggregated and shared back to the Commission in a stakeholder letter.

#### **Communities of Practice Program Update**

Nataly Diaz and Nichole Mosqueda, Camarena Health, discussed the collaboration with UCD's Center for a Diverse Healthcare Workforce to create a Communities of Practice forum to explore ways to increase the number of students from Far North and San Joaquin Valley who attend UCD School of Medicine, and who will likely choose to return to those communities to practice once they complete their medical education training. The goal of the Communities of Practice is to create an Endorsed Applicant Partnership process by February 2019.

# **Residency Advocacy & Research**

Nataly Diaz reported that the Song-Brown Commission met on June 13th and 14th to consider policy proposals from OSHPD staff and stakeholders that will affect the way scoring occurs and grants issued at future meetings. DHCS is submitting the SPA to authorize reimbursement under the PPS methodology for services performed by qualifying Graduate Medical Education (GME) primary care residents at FQHCs and RHCs. CPCA submitted comments to DHCS requesting that they broaden the coverage so more of our members can benefit.

# **HRSA's Shortage Designation Modernization Project**

Nataly Diaz explained that over the past year, CPCA has been involved in conversations with NACHC and HRSA about potential changes to the shortage designation process and communicated them to the CPCA membership via the Workforce Committee meeting and email updates.

# I. Current State of California Health Center Residency Programs Report

To expand the existing knowledge set around the current state of residency programs in California's health centers, CPCA commissioned Schoen Consulting to complete an environmental scan between June 2017 and February 2018. In addition to primary care medical residency programs, research was also conducted around the postgraduate training of nurse practitioners and physician assistants (NPs/PAs) given their impact on workforce development in health centers. A total of 35 California health center and consortium staff, as well as industry experts, were interviewed for this report. The executive summary and full report can be found via the link that is noted in the resources section below.

# II. CPCA Residency Training & Technical Assistance Program

The California Primary Care Association (CPCA) is committed to increasing primary care workforce capacity for California's CHCs. Building off of our joint success with the \$100M state investment in primary care residency programs, we received a grant to programmatically support the development of new, existing, and expanding CHC residency programs. The goals of the program are to:

- Develop comprehensive trainings and resources for CHCs desiring to implement or sustain residency training programs or partnerships
- Increase the number of new CHC residency partnerships and accredited programs to expand primary care GME in California
- Strengthen and sustain existing CHC residency partnerships and accredited programs to maximize ongoing efforts that train primary care residents in community-based settings and underserved areas

As a result, we developed a 13-member Residency Advisory Group that will help the CPCA project team identify graduate medical education (GME) challenges and brainstorm potential trainings and resources for the CPCA Residency Training and Technical Assistance (TA) Program. In the next couple months, we will convene our advisory group to help us think through the organization of residency-related trainings and webinars in 2019. # III. August 23<sup>rd</sup> Song Brown Commission Meeting

In addition to securing the second third of the \$100M to the Song-Brown Commission for FY18-19, CPCA also advocated strongly for community health center primary care residency program applicants at the August 23<sup>rd</sup> Song-Brown Primary Care Residency Funding Meeting. We were pleased to see that \$9.3 million (25%) of the total funds were awarded to new, existing, and

expanding health center accredited residency programs. Congratulations to the nine health center applicants that were awarded funding to support their workforce development efforts:

- Shasta Community Health Center,
- Family Health Centers of San Diego,
- Clinica Sierra Vista,
- Valley Health Team,
- SAC Health System,
- Borrego Health
- North East Medical Services,
- LifeLong Medical Care, and
- San Ysidro Health

The August 23<sup>rd</sup> Song-Brown meeting was strictly for funding decisions, therefore, the Commission did not make any policy decisions. We expect that OSHPD will schedule additional stakeholder meetings to discuss a definition for "economically disadvantaged", continuity of care at training sites, identification of applicant names in funding meetings, etc. CPCA will continue to engage in these conversations with OSHPD, the California Academy of Family Physicians, and the California Medical Association.

# IV. Prop 56 Graduate Medical Education Funds

The legislature and administration reached an agreement on the FY 18-19 spending plan for the Proposition 56, California Healthcare, Research and Prevention Tobacco Tax Act of 2016 revenue. This investment included a one-time \$40 million investment in family medicine, pediatrics, OB/GYN, internal medicine, and emergency medicine residency programs. The funds will be used to achieve goals as reflected in Prop 56, including sustaining, retaining, and expanding graduate medical education programs to increase the number of primary care and emergency physicians in California.

These voter approved funds are going to University of California, but will be disseminated via the fund's selected third party administrator (Physicians for a Healthy California, formerly named the CMA Foundation). Lupe Alonzo-Diaz is the new President and Chief Executive Officer of the Physicians for a Healthy California, and invited CPCA to participate in a 15-member Advisory Council. CPCA nominated Dr. Debbie Lupeika, Shasta Community Health Center's Residency Program Director, to sit on the panel given her expertise and active engagement at the Song-Brown Commission meetings. While an application process still needs to be created, and criteria refined, we expect Teaching Health Centers and other ACGME-accredited health center residency programs to be eligible for these funds.

# V. Teaching Health Center Graduate Medical Education Program

CPCA recently engaged in discussion with Luis Padilla regarding Teaching Health Center Graduate Medical Education (THCGME) funding, and was informed that funding for existing programs will cover years 2018, 2019, and early 2020. Funding for existing programs will be available at a per resident amount (PRA) of \$150,000. Although language was included in the budget act to support both current and new THCs, HRSA is in the process of balancing their budget and evaluating the appropriateness of funding allocation for new THC programs. This decision comes with the recognition that Congress only extended the THCGME program for two years. They would like to secure another round of funding next year and disseminate the funds at a time when the federal program is sustainable and three years' worth of funding is available. While we appreciate the

intention, CPCA is concerned about this decision's impact on the growth of newly developing residency programs. For this reason, we wrote a letter to HRSA in conjunction with our members to express our concerns. We specifically urged them to disseminate the funds as soon as possible to not halt the significant progress our state and health centers have made to develop residency training opportunities in our communities. # VI. Pending SPA 18-0032: GME/PPS

DHCS submitted SPA 18-0032 to CMS on June 29, 2018 to authorize reimbursement, under the Prospective Payment System (PPS) methodology, for services performed by qualifying Teaching Health Center Graduate Medical Education (THCGME) Primary Care Resident Physicians at participating Federally Qualified Health Centers (FQHC) and Rural Health Clinics (RHC). Currently, services performed by primary care resident physicians at FQHC and RHC sponsored THCGME programs are not eligible to be reimbursed on a per visit basis. SPA 18-0032 will authorize reimbursement of services performed by qualifying primary care resident physicians, under the supervision of a teaching physician at FQHC and RHC sponsored THCGME programs.

SPA 18-0032 is still pending approval and if approved will be effective April 1, 2018. CPCA submitted formal comments to DHCS on June 29, 2018 after obtaining member feedback. Our letter requested that they broaden the coverage to any FQHC or RHC with an accredited ACGME-accredited program or continuity training site with the goal of extending this benefit to more of our members. We have had several calls with DHCS to vocalize our recommendations and share residency expertise, but are still unclear whether DHCS is incorporating our comments. Regardless, we will continue to engage with them to advocate for this expansion.

**M**EMORANDUM

# I. BACKGROUND & OVERVIEW

CPCA continues to focus extensively on care team development in the community health center setting, and works to identify and promote effective care team structures that support the delivery of quality, comprehensive health care in a timely and efficient manner. Medical Assistants (MAs) play a critical role in providing care and expanding capacity within care teams, and CPCA has worked to provide technical assistance and resources aimed at effectively utilizing MAs. CPCA consistently hears from members that it is challenging to recruit qualified MAs with the skills necessary to provide care in complex health center settings; and that it is equally challenging, if not more so, to retain those MAs for more than 12-24 months once trained.

To aid community health centers in their efforts to successfully onboard and retain qualified MAs, CPCA intends to develop a Medical Assistant training program and accompanying careerladder development guide. We seek Workforce Committee input to ensure our efforts in providing an MA training present themselves as resources community health centers can utilize to their benefit.

# II. MEDICAL ASSISANT RETENTION & TRAINING PROGRAM

For several years, CPCA staff have fielded workforce questions and concerns specific to recruiting, training and retaining Medical Assistants. In the last 18 months, CPCA has had iterative conversations with health centers and regional associations alike about how best CPCA can address these challenges from the state office. Recognizing that in some cases, health centers and/or regional associations have developed their own MA-specific training and career ladder programs, it is our goal to help scale these efforts and/or make available similar resources where there is currently no access to such programs.

CPCA seeks to achieve a singular objective with a Medical Assistant training and retention program: To improve qualified Medical Assistant retention rates within community health centers. To achieve this objective, CPCA has developed the following two goals

- Goal 1: To develop a "CHC immersion" training program that, alongside a health
  center's specific onboarding process, will introduce newly trained MAs to care delivery
  in a community health center setting, thereby allowing an MA to quickly integrate into
  the CHC workforce.
- **Goal 2**: To develop an MA Career Ladder Guide or Toolkit to help health center leaders identify the resources and considerations needed for creating professional development pathways that enable them to retain qualified MAs.



# **Next Steps**

CPCA has retained Macman Management Healthcare Services to help organize and facilitate a member advisory group, who will:

- Work to identify health center specific challenges/problems around MA recruitment, training and retention efforts;
- Identify needed curriculum that would better orient an newly hired MA to care delivery
  in a health center setting, thereby improving the chances of an MA staying in the safety
  net; and
- Help develop an employer-specific resource that would support health centers develop tailored MA career ladder programs.

In addition to health professions training subject matter experts, the member advisory group will largely be comprised of health center and regional association workforce leaders. The advisory group will come together from now through January 2019 to help CPCA address this important workforce challenge.

The Personal Income Tax Law and the Corporation Tax Law allow various credits against the taxes imposed by those laws. Re: California Budget 2018-19 Implementation Update: Workforce

**M**EMORANDUM

On June 27<sup>th</sup>, Governor Brown signed his final state budget of this term, and of his storied career in public service. As reported in July, the Budget Act of 2018 includes a number of workforce-related investments. In the paragraphs below, implementation updates on these items are provided:

# \$100 Million Workforce Funding Continues:

Summary: After the reinstatement of these funds in the FY 17-18 Budget, the enacted budget reaffirms the administration's commitment to primary care workforce by moving forward with the 2<sup>nd</sup> of 3 installments to increase funding to the Office of Statewide Health Planning and Development (OSHPD) Song Brown Program that invests in primary care residency in underserved communities. The budget act appropriates \$31.3 million, the 18-19 portion of those funds. Consistent with the Budget Act of 2016 and the Budget Act of 2017, these funds are to be allocated through Song-Brown in the following manner:

- \$18,667,000 to existing primary care residency programs,
- o \$5,6667,000 to primary care residency slots for existing teaching health centers
- \$3,333,000 to new primary care residency slots at existing primary care residency programs
- \$3,333,000 to newly accredited primary care residency programs. As of June 30, 2021, unspent amounts may be redirected to fund new residency slots at existing programs if newly accredited primary care residency programs have not been established.

Additionally, \$333,000 of these funds is made available to the State Loan Repayment Program.

Implementation Update: Please refer to the Memo in this Workforce Committee packet titled, Support for Community Health Center Primary Care Residency Programs, for an update on awards. CPCA staff will continue to actively engage the commission, attending policy meetings and providing written comment, to guarantee that policies of the Commission do not unduly burden future applicants and disadvantage health centers.

# • Primary Care Clinician Psychiatry Fellowship:

Summary: The enacted budget contains one-time health workforce investments to be directed through the Office of Statewide Health Planning and Development (OSHPD). One-time \$1,000,000 is available to fund scholarships for primary care and emergency physicians receiving Primary Care Clinician Psychiatry Fellowships from either the University of California at Davis Medical School or the University of California at Irvine Medical School.

Implementation Update: According to our partners at the California Psychiatric Association, OSHPD contracts with the University of California are currently being finalized. Once contracts are completed, OSHPD will be marketing this opportunity and distributing the application.

Advocates are hopeful the application will be ready in October. In the interim, providers can enroll in the fellowship starting today, and as soon as the scholarship application is ready, the program will contact the enrollee and facilitate its completion and transmittal to OSHPD. See resource section for link to enroll in the fellowship.

# Proposition 56

**Summary:** The legislature and administration reached an agreement on the FY 18-19 spending plan for the Proposition 56, California Healthcare, Research and Prevention Tobacco Tax Act of 2016 revenue. Similar to 2017, over a billion dollars is projected to flow to Medi-Cal in 2018-19. In addition to supplemental provider payments, funds will be directed to two workforce programs. See below for additional details:

Physician/Dentist Loan Repayment Program: Establishes the Proposition 56 Medi-Cal Physicians and Dentists Loan Repayment Act Program to provide loan assistance payments to qualifying, recent graduate physicians and dentists that serve Medi-Cal beneficiaries. OSHPD and stakeholders will be consulted in the programs design and eligibility criteria, but the program will be administered by DHCS. One time funding of \$220,000,000 will be allocated for these purposes (\$190,000,000 for recent graduate physicians and \$30,000,000 for recent graduate dentists).

Implementation Update: To date, we have not, regrettably, received any update from DHCS on the implementation timeline for the Proposition 56 loan repayment program. DHCS' Proposition 56 implementation website has also not been updated to reflect this new program. We will continue to outreach to stakeholders and DHCS to get a timely update on implementation.

Residency: One-time \$40 million investment in primary care and emergency medicine residency. These voter approved funds will now go to University of California and the fund's selected third party administrator – Physicians for a Healthy California (CMA Foundation). While an application process still needs to be created, and criteria refined, these funds are to be distributed to five specialties – emergency medicine, family medicine, pediatrics, OB/GYN, internal medicine. We expect Teaching Health Centers to be eligible for these funds

Implementation Update: This August, Physicians for a Healthy California, reached out to a variety of statewide associations, including CPCA, to solicit participants for the Graduate Medical Education (GME) Advisory Council. This Council will play a critical role in the implementation of the Proposition 56 residency funding. CPCA is excited to share that Dr. Debra Lupeika, MD, Residency Program Director for Shasta Community Health Center, will be representing health center interests on the Council. The first meeting of the Council will be held on September 27<sup>th</sup> and will focus on governance and timeline for the Council, review initial principles, and discuss program criteria and funding levels.

#### Conclusion

With implementation on many of the above mentioned budget items just launching, CPCA staff are committed to updating the membership and this committee on implementation developments.

Re: Area Health Education Center (AHEC) Program

#### I. CPCA Letter to HRSA

HRSA announced a new five-year grant cycle for the Area Health Education (AHEC) Program in 2017. The grant guide detailed a new AHEC Scholars program requirement in which recipients must support the development and implementation of a longitudinal, interdisciplinary curricula. This material is intended to set clinical, didactic, and community-based training activities in rural and/or underserved areas for a cohort of health professions students. The AHEC Scholars Program will supplement students' existing health professions programs. At a minimum, each cohort of the AHEC Scholars Program must last for two years and culminate in completion or graduation from a degree or certificate program.

This new grant requirement is intended to achieve positive workforce outcomes, but the inflexibility of student eligibility has posed implementation challenges for our community health centers (CHCs) and regional consortia, which serve as the majority of the California AHEC sites. Some health centers in our state, especially those in rural areas, are challenged to carry out the goals of the AHEC Scholars Program per current regulations because they are not located near academic institutions. In addition, new models of organized training for nurse practitioner, physician assistant, and medical residents have emerged in the recent years and could align well with the AHEC Scholars Program. For these reasons, along with the fact that dedicated funding and support is needed to ensure the program's success and sustainability, CPCA recommended the following recommendations to HRSA:

- Expand student eligibility beyond current limitations to include medical residents, nurse practitioner and physician assistant post-graduate trainees
- Utilize AHEC fiscal bumps in the future or other funding available now to offset the increased unfunded costs of implementing and administrating the AHEC Scholars
- Organize additional grantee webinars to provide guidance and share best practices

These concerns and recommendations were shared with Jim Macrae at the CPCA/HRSA meeting at CHI. CPCA also had a conference call with Luis Padilla on September 21<sup>st</sup> to obtain his feedback. NACHC, CA AHEC, and HANC were present. HRSA shared with us an interest to support our statewide implementation of the AHEC Program, but due to limitations with the current grant cycle, could not make changes to the existing grant guidelines. Overall, he is supportive of our efforts and will look at how to potentially incorporate residents in the larger AHEC Program activities. CPCA will continue these discussions with HRSA, especially as AHEC may receive a \$1 million bump in funding next year.

# I. HRSA's Shortage Designation Modernization Project

HRSA continues to move forward in its efforts to modernize the shortage designation process with automated procedures and standardized data sets. The previous issue we identified in defining provider FTE default was resolved, and states will be allowed to utilize statewide data before resorting to national averages. This was a true success for California because utilizing national averages could have significantly lowered the HPSA scores for many of our health centers. CPCA worked closely alongside NACHC, OSHPD, and other PCAs to make this happen, and thank them for their efforts. As part of this process, OSHPD was able to upload 2016 Medicaid claims data into the Shortage Designation Management System to update provider FTE data statewide. This helped meet HRSA goals of updating data and addressed concerns shared by other states previously.

We now wait for the release of the first impact analysis, which we anticipate will be individually disseminated to health centers in early-mid October. These impact analyses will specifically be sent to the CHC contacts noted in HRSA's electronic handbook. We recommend that all CHC staff noted in HRSA's electronic handbook add "HRSA GEMS" (oitgems@hrsa.gov) to their "safe senders" or contacts list to avoid having this important message go to their junk folder. We also recommend that CHC staff review once again the PowerPoint slides created for the OSHPD/CPCA Shortage Designation Modernization Project webinar on June 27<sup>th</sup>. They detail the potential HPSA changes and demonstrate a template of the monthly impact analysis CHCs should receive in the coming weeks. Please keep in mind that no official changes will be made to HPSA scores until spring 2019. The impact analyses that will be released by HRSA between October 2018 and February 2019 are intended to evaluate the impact of the potential changes if they were to move forward.
