The education program will be focused to accuracy of documentation and reporting of diagnosis and ambulatory/outpatient procedures. This role will partner with existing health center staff, processes, and tools to maximize efforts and will utilize findings of the Coding Chart Abstractor daily activities and network audit tools to customize education and outreach. The position will be based in the clinically integrated network but will spend substantial time at/with health centers providing educational sessions, answering questions, and updating processes and tools for the network. This position will plan a key role in ensuring clinician, billing staff, and leadership understanding of accurate coding and documentation for billing and documentation purposes. The role will partner with Coding Abstractors, Operations team members, FQHC providers and billing staff, and network leadership to design/update educational programs, complete rapid cycle performance improvement efforts, provide statistics of coding efforts, and ensure compliance with payer and industry standards. This position actively supports the mission and vision of Health Center Partners of Southern California and its subsidiaries helping to develop high performing practices that will thrive in an environment changing from volume to value.

- Develop and/or maintain a network coding education and outreach program for clinicians and billing staff to ensure compliance to industry standards of diagnosis and procedure coding as well as payer billing compliance.
- Complete onsite and virtual coding and billing trainings for clinicians and billing staff based on predefined coding education and outreach modules and annual plan.
- Utilize network designated coding audit tools and technology to perform monthly audits and identify high risk providers and/or practices for outreach and education.
- Complete monthly statistic reports inclusive of reporting, compliance, and risk trends to provide to executive network leadership for progress tracking and risk mitigation planning.
- Educate network Coding Chart Abstractors based on monthly audits and trends, in addition to clinicians and billing staff.
- Partner with MSO (Management Service Organization) and network Population Health IT
  Management Team to communicate education series, trends, and network process updates.
- Partner with Operations Practice Liaisons to implement and/or update network best practices within health centers based on audit and education session findings.
- Ensure compliance with industry, state, and network / payer coding practices.
- Maintain relationships with health center clinical providers to be an asset for questions pertaining to coding and documentation.
- Maintain competencies regarding diagnosis and procedural coding based on industry or market/payer updates.
- Document work, display results effectively and appropriately and contribute content for regular progress reports.
